### COMMERCIAL TERMS AND CONDITIONS FOR SUPPLY.

#### 1. PRICES

- a. The bidder should quote FIRM prices on FOR destination basis inclusive of packing, forwarding freight charges and all taxes & duties.
- b. Sales tax registration number of the firm should be indicated in the offer.

#### 2. EARNEST MONEY

The bidder shall deposit the Earnest money Rs. 5000/- deposit amount based on the value of the materials offered, mentioned in the tender:-
