The initial contract will be for a period of 3 years. Candidates may send application form duly filled up through registered post or in person along with copies of necessary certificate/ documents on or before 30th September 2009, with application fee of Rs 500/- (non refundable) in the form of DD in favour of “**Senior Accounts Officer, HOAU, MPMKVCL, Bhopal**” , addressed to the: Joint Secretary(S) O/o CMD, MP Madhya Kshetra Vidyut Vitaran Co. Ltd, Nishtha Parisar, Govindpura, Bhopal - 462023.

1. Experience :

(a) System Analyst:-

Minimum 3 years experience in implementation of complete cycle of at least 1 ERP module along with thorough knowledge of understanding of all the functions of ERP and integration of its different modules. He/she should possess skills of web based computing, database management system and real time software development.

(b) System Developer:-

Minimum 1 year experience in Application/Implementation of ERP or in system integration Project or in Networking project from an organization of repute, Government undertakings or PSUs. Preference shall be given to candidates having experience in implementation of **ERP** module.

(c) Programmer:-

Minimum 1 year experience in Application/implementation of ERP or in system integration Project or in Networking project from an organization of repute, Government undertakings or PSUs.

2. Remuneration:

Fixed monthly remuneration of Rs.30,000 for System Analyst, Rs.25,000 for System Developer and Rs.25,000 for Programmer. Annual increase in remuneration will be considered on the basis of performance of last year.

3. Age Limit:

Not more than 35 years for System Analyst as on 01.09.09 ..

Not more than 30 years for System Developer or Programmer as on 01.09.09 . SC/ST/OBC category candidates will get relaxation in upper age limit to an extent of five years.

4. Contract Period:

Three years, extendable for a further period of two years

5. Selection Procedure:

a) The applications of all the candidates shall be screened by the members of the Screening Committee.

b) Selected candidates may have to appear for a written examination followed by interview.

6. Only candidates with domicile in M.P shall be eligible to apply for reserved category post. Copy of Domicile certificate issued by S.D.O must be attached by such candidates.

7. Application fee:

For unreserved/OBC category candidates **Rs. 500/-**(non refundable) only payable through demand draft in favour of Senior Accounts Officer, HOAU, MPMKVVCL, Bhopal. **No application fee is chargeable from SC/ST Category candidates.** (Write your name and post applied for at the back of the DD). Candidates applying for more than one post will have to fill up separate application form with application fee for each post.

8. General Conditions:-

- a) Candidates working in the Government/Semi-Government/Public Sector satisfying the eligibility criteria of education and age shall have to apply through proper channel or else they have to produce N.O.C at the time of interview failing which they will not be permitted to appear for the interview,
- b) SC/ST/OBC posts shall be applicable only for candidates possessing M.P. domicile.
- c) SC/ST candidates will be reimbursed to and fro second class rail/bus fare by the shortest route for appearing in the written test and personal interview.
- d) Any dispute arising out of the selection process will be dealt with in the jurisdiction of Bhopal courts only.
- e) The candidates must produce original documents/certificates at the time of interview in support of their qualification and experience.
- f) Experienced candidates will be preferred.
- g) These posts are temporary in nature for specific period as mentioned.
- h) Candidates applying for more than one post have to fill up separate application form with application fee for each post.
- i) Candidates not having the desired experience need not apply.

9. Last date:

Application in the required format along with requisite attested copies of certificates and application fee should invariably reach the Joint Secretary(S), O/o CMD, Madhya Pradesh Madhya Kshetra Vidyut Vitaran Co. Ltd., Bhopal-462023 on or before 30.09.09. Applications received after due date shall be liable for rejection.

10. Documents to be attached with application:

- b) Graduation/post graduation or equivalent qualifications certificate along with each semester mark sheet (attested photocopies).
- c) Work experience certificate duly attested.

- e) Domicile certificate duly attested in case of candidates applying for reserved posts.
- f) Candidates serving in the government / Semi government / Public Sector should submit NOC from the employer.
- g) DD of Rs.500/- (non refundable).
